Notice Inviting Tender for “CONSTRUCTION OF BOUNDARY WALL, INTERNAL ROAD, SECURITY ROOM, GATE ETC. FOR DRY FISH MARKET AT HUMA IN GANJAM DISTRICT OF ODISHA UNDER DIRECTORATE OF FISHERIES ODISHA, DEPARTMENT OF FISHERIES & ANIMAL RESOURCES DEVELOPMENT DEPARTMENT, GOVERNMENT OF ODISHA.”

Tender document will be available from **01.03.2024 to 14.03.2024**. Last date of submission of offer is **14.03.2024**. Interested parties meeting the following eligibility criteria can collect **the Tender Document, Technical Specification & SOQR** from Bridge and Roof’s Zonal Office against a request letter.

ELIGIBILITY CRITERIA

1. Qualifying Criteria for participation in Tender:-

The bidder should have successfully completed “**Similar Works**” of following value during the last **07 (Seven) years** ending last day of month previous to the one in which offer(s) / bid(s) are invited should be either the following:

- a) 01 (One) similar completed work costing not less than **Rs. 146.33 Lakh,**
Or
- b) 02 (Two) similar completed works each costing not less than **Rs. 91.46 Lakh,**
Or
- c) 03 (Three) similar completed works each costing not less than **Rs. 73.16 Lakh.**

“**Similar Work**” shall mean a Project comprising **Execution of a Residential/Industrial/Infrastructure Building Project consisting of Civil Work, Electrical Work, Sanitary & Plumbing Work etc.** in all respect in a single agreement/ Contract

Notarized copy of **Completion Certificate** mentioning executed value of work & date of completion along with corresponding LOI/WO duly certified by clients from an officer not below the rank of EE or equivalent, substantiating the above mentioned criterion under Sl. No. 1 as well as value of work to be submitted.

In case the Bidder is executing a Project, then Client / Owner has issued Completion Certificate in respect of a part of work, (more than 90% of the value of work has been completed) which meets the eligibility criteria, the same shall be considered while evaluating the Technical Bid.

Experience should be in the name of the bidding Company and not in Subsidiary / Associate Company / Group Company etc.

In case the work experience is of Private Sector, the completion certificate shall be supported with copies of letter of award and copies of corresponding TDS Certificates along with the copy of relevant certified invoice. Value of work will be considered equivalent to the amount of TDS Certificates duly Notarized.

2. The bidder should be financially sound and should have a minimum average annual turnover of last three Financial year ending 31.03.2023 of **Rs. 54.87 Lakhs (Fifty Four point Eight Seven Lakhs) or above**. Turnover should be of the Bidding Company and not for Subsidiary / Associate Company /Group Company etc.
3. The Bidder should not have incurred any loss (**Profit after Tax should be Positive**) in more than two years during the last five years ending **31st March, 2023**.
4. Bidder The bidder should have **PAN, GST Registration and Current Income Tax Deposition Document**.
5. The Bidder should have Filed Latest **Monthly / Quarterly GSTR-3B Return** towards GST Clearance Certificate.
6. The bidder should be able to abide by and handle statutory requirements related to **Labour License, PF & ESI Registration** Certificate during tenure of construction activities. (if not registered with Concerned Department(s), Successful Bidder must take Registration within one month from the date of Award and in this regard bidder has to submit an undertaking in their Letter Head for the same.)
7. Bidder(s) have to submit copy of valid Electrical License or, Bidder must associate himself with Agencies for Electrical Work having valid Electrical License. Therefore, Bidder have to submit Willingness Certificate as per specified format from Associating Electrical Agency along with valid Electrical License.
8. Bidder(s) (Only Private Limited / Limited Company) should submit the Copy of Screenshot of MCA Portal showing 'Active' Status. Non-submission of above status, their offer may be rejected for further evaluation.
9. **Direct or Indirect Joint Venture(s) / Consortium/ Special Purpose Vehicles (SPV)/ Special Purpose Entity (SPE) are not allowed to participate.**

The cost of Tender Document (non-refundable) is **Rs. 5000.00 + GST @ 18%** (Rupees Five Thousand plus 18% GST only) and the EMD amount is **1.83 Lakhs** (Rupees One point Eight Three Lakhs).

Bidder shall submit Demand Draft / Pay Order / Banker's Cheque of any Nationalised Bank in favor of Bridge and Roof Co. (India) Ltd., payable at Bhubaneswar towards Cost of Tender Document along with the Techno-Commercial Offer.
